Your subscription entitles you to Provisional/Ordinary Membership of the Dabblers' Social Club Inc for a period of twelve months from the date of acceptance by the Management Committee of the application for Provisional Membership. Members become Provisional Members for the first three months and then their application automatically comes before the Management Committee for consideration for Ordinary Membership of the Club. Provisional members have full voting rights at a General Meeting, but are not eligible for the Club's Management Committee. Under the Dabblers Constitution it is a condition of membership that all members host or co-host at least one function per year. This adds variety to the activities as well as sharing the workload.
